According to SPPRA, Rules, Single stage – Two envelope bids, containing Technical and Financial Proposals, were invited for the purpose.

In response to advertisement, Five (05) interested firms purchased the tender documents out of which Four (04) firms submitted their Technical & Financial bids (Attendance Sheet annexed at "A").

Accordingly, the Technical Proposals were opened by the Procurement Committee as on 24.03.2021 in presence of the representatives of Bidding Firms. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in services in relevant field, after preliminary evaluation of documents M/s. Nayab enterprises has disqualified due to non fulfillment of eligibility criteria and following firms were found technically qualified (Eligibility / Qualification Report annexed at "B"):


