The proceeding of the meeting started with the recitation from Holy Quran. Thereafter The Secretary Board being convener of the Committee has informed that sealed bids were invited through press for **Printing of Tabulation Registers Annual Examination 2023** published in leading newspapers; Daily Express Tribune (English) as on September 13, 2023 as well as Daily Jang (Urdu) on September 14, 2023 and Kawish (Sindhi) as on September 13, 2023. The same was hoisted on the website of BIE Karachi as well as SPPRA at Sr. No. T00535-23-0005 dated 16.09.2023. According to SPPRA, Rules, Single stage - One envelope bids, containing Technical and Financial Proposals, were invited for the purpose.

In response to advertisement, **Four (04)** interested firms purchased the tender documents and **Four (04)** of them submitted their bids (Attendance Sheet annexed at "A") which are as follows:

- 1) M/s. Paradise Press Pvt. (Ltd.)
- 2) M/s. Shan Printing Press
- 3) M/s. Benison Printers
- 4) M/s. Mighty Deals

The bids were opened by the Procurement Committee in due course of given time i.e. at **03:00 PM** dated **22.09.2023** in presence of the representatives of Bidding Firms and the rate quoted by bidders were announced one by one. Committee preliminary evaluated the bids technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in supply of similar stores, committee has satisfied after preliminary evaluation of the documents submitted by the bidders announced as all **Responsive** (Eligibility report annexed at "B") with referred to the criteria mentioned in bidding documents.
