- (2) Attachment of Photocopy of Enrolment Card/Registration Card and Admit Card or Marks Sheet is essential.
- (3) It is pointed out that Migration Certificate once issued shall not be issued again until and unless details of lose of Original Migration are provided to the Board, hence, its care is essential. Moreover, Migration Certificate shall only be issued to Original candidate only.
- (4) Urgently required document shall be issued on the date given by the office. Under Normal Fee, required document shall be issued after 15 working days, ignoring holidays and, if, last day is a holiday then it will be issued on next working day.
- (5) Form must be filled in carefully and completely. Incomplete forms shall not be accepted.
- (6) All required documents must be collected within 30 days of the issuance date, after that these documents will be discarded & candidate will have to submit a new form along with prevalent fee.

NOTE: In case of giving incorrect information or filling in form wrongly a new date shall be given by the office.

In case of issuance of **Duplicate Migration Certificate**, the candidate will have to let this office know that when, where and how his/her Original Migration Certificate lost.
