

Meeting started with the recitation from Holy Ouran. The Committee was informed that sealed bids were invited through press for **Printing of Tabulation Registers** was published in leading newspapers; Daily DAWN (English) as on October 10, 2021 as well as Daily Jang (Urdu) on October 10, 2021 and Daily Sobh (Sindhi) as on October 11, 2021. The same was hoisted on the website of BIE Karachi as well as SPPRA at Sr. No. T00535-21-0005 dated 18.10.2021. According to SPPRA, Rules, Single stage - One-envelope bids, containing Technical and Financial Proposals, were invited for the purpose.

In response to advertisement, **six** (06) interested firms purchased the tender documents and **five** (05) of them submitted their bids (Attendance Sheet annexed at "A") which are as follows:

- 2) M/s. Ubaid Enterprises, Karachi
- 3) M/s. Mighty Deals, Karachi
- 4) M/s. Sana Printers, Karachi

The bids were opened by the Procurement Committee on 18.11.2021 in presence of the representative of Bidding Firms and the rate quoted by bidders was announced. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in supply of similar stores, committee has satisfied after preliminary evaluation of the documents submitted by the bidders and announced all of them **Responsive** in Bid Qualification Report (as annexed at "B") with referred to the criteria mentioned in bidding documents.

The committee first reviewed the specification required by the Board and also given bidding documents and thoroughly examined & evaluated the samples furnished by the bidders one by one

After announcement of rates the detailed comparative statement for items was prepared by the Committee and the same are attached with minutes (as Annexure "C"). The summarized position of the Financial Proposals is given as follow:-
